

## Assumption of the Risk & Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

CREO Arts & Dance Conservatory has put in place preventative measures to reduce the spread of COVID-19; however, CREO cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending CREO could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending CREO and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at CREO may result from the actions, omissions, or negligence of myself and others, including, but not limited to, CREO employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at CREO or participation CREO classes ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless CREO, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of CREO, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any CREO program.

I voluntarily agree to adhere to the preventative measures CREO has put into place including having my temperature and my child(ren's) temperature taken at CREO.

I voluntarily agree to wear a mask and to have my child wear a mask at all times while in the CREO building. *Dancers enrolled in age 3-4 and 4-5 year old classes are not required to wear masks.*

I voluntarily agree that no one from my household will enter the CREO building should anyone in my household test positive or show signs or symptoms of COVID-19 stay at home at least 7 days or for 72 hours with no fever and improvement of respiratory symptoms - whichever is longer.
